All livestock and crop investments are covered by our insurance and depreciation fund. This includes vet fees, death loss, and depreciation losses on the investment in livestock.


How Will I Market The Livestock Or Crop?

You will market the livestock or crop in the name of STEER, Inc. If you are selling some of your own livestock or crop at the same time, you can simply take the overall average and have the marketing agent make the check payable to STEER, Inc. for the portion which is designated to missions. By not involving your personal account you will not have to declare as income or pay Social Security Tax on the STEER Project.

When Sold, What Amount Is Paid Out To The Mission?

A large percentage of the gain goes to the mission as designated by the farmer. The remaining portion is used for replacement costs, death and depreciation losses and administration. The original investment (donor UNIT) is always retained to be reinvested in another project. (For updated percentages, contact the STEER office.)

On short term investments such as feeder cattle and God's Acres, the gain is the amount remaining after the original investment is deducted. On long term investments such as beef cows, hogs, etc., the offspring become the gain. The milk is the gain on dairy cows. The dairy cow's offspring is used to reduce the higher purchase cost on this kind of investment.
